



Advertising Privacy Policy Affilsearch Privacy Practices for our website

Affilsearch.co.uk (the "Website") is an Internet property of Affilsearch. ("us" or "we"). We provide this privacy policy ("Privacy Policy") so that we may inform you about how our technology ("Technology") processes information on behalf of the online Merchants, website owners and other businesses that use our services. This Privacy Policy also outlines our privacy practices on our corporate website ("Website") located at www.affilsearch.co.uk. You agree to this Privacy Policy, in its entirety, when you: (a) access or use the Website; and/or (b) apply for the affiliate ("Affiliate") and/or merchant ("Merchant") and together with the Affiliate's, "Clients") services available through the Website ("Services"). If you do not agree with the terms and conditions of our Privacy Policy, please do not use or access the Website or apply for the Services.

Personally Identifiable Information:

We collect Personally Identifiable Information ("PII") from this Website when you attempt to become a Client or otherwise choose to provide PII to us. PII is any information that can be used to identify or locate a particular person or entity. This includes, but is not limited to the following: name, address, telephone number, mobile number and/or email address. For example, you may choose to send us PII about yourself in an email or by completing an online form on our Website. Once collected, we will store your PII for a reasonable period of time for record keeping purposes. The information that we store is sometimes deleted as space requires or in the normal course of business.

Information Sharing:

Affilsearch will not sell, share or rent your PII to or with others. Your PII is not shared with any third parties, except: (a) where necessary to conduct business, such as invoicing Clients in connection with the Services or making payments to, or collecting money from, a Client; (b) in the case of a breach of any agreement between Client and Affilsearch; (c) where required by law, or requested by a court of competent jurisdiction; (d) (c) in the event of Affilsearch bankruptcy, or if Affilsearch is sold or acquired; or (e) where Affilsearch determines, in its sole discretion, that such disclosure is necessary to protect the rights of Affilsearch and/or a third party, or necessary to protect Affilsearch from liability of any kind.

Non-Personally Identifiable Information:

We collect Non-Personally Identifiable Information ("Non-PII") from Website visitors. Non-PII is information that cannot by itself be used to identify a particular person or entity, and may include your IP host address, pages viewed, browser type, Internet browsing and usage habits, Internet Service Provider, domain name, the time/date of your visit to our Website, the referring URL and/or your computer's operating system.

Cookies and Web Beacons:

We use "cookies" and web beacons to help us manage our Website. Cookies are small text files that contain a string of alphanumeric characters. Web beacons (also known as "1X1 pixels" or "clear GIFs") are small strings of code that provide a method for delivering a graphic image on a web page or in an email message for the purpose of transferring data. Web users have the option of blocking the use of cookies by changing a setting in their browser. Web users can check their browser supplier's website for details on how to do this. Minors:

This Website is not intended for visitors that are under eighteen (18) years of age. Affilsearch does not knowingly solicit or collect information from individuals under the age of eighteen (18). If we determine that we have inadvertently collected PII from someone under eighteen (18) years of age, we will take reasonable steps to purge this information from our database.

Security:

All collected information is stored in a technically and physically secure environment. While we use SSL encryption to protect Sensitive Information online, we also do everything in our power to protect PII (including Sensitive Information) off-line. Unfortunately, no data transmission over the Internet can be guaranteed to be 100% secure. As a result, while we strive to protect our end-users' PII, we cannot ensure or warrant the security of any information that you transmit to us, and you do so at your own risk.

Once we receive the transmission of your PII, we make reasonable efforts to ensure its security on our systems. Access to this information is strictly limited, and not accessible to the public. All our end-users' PII is restricted in our office. Only employees who need the information to perform a specific job (for example a customer service representative) are granted access to PII.

Affilsearch reserves the right to change or update this Privacy Policy at any time by posting a clear and conspicuous notice on the Website explaining that we are changing our Privacy Policy. Privacy Practices Applicable to Our Technology:

Affilsearch clients are primarily businesses. Our Clients use our Technology to help deliver online advertisements to consumers while they are online.



Types of Information that We Collect Via Our Technology:

Personally Identifiable Information:

We don't collect PII via our Technology.

Non-Personally Identifiable Information:

As with all web content delivery systems, our Technology records information about the interaction between a web user's browser and our servers. Those interactions include advertisement content (banner) delivery, counting click-throughs on an advertisement, and tracking web page views after a click-through. Browsers typically provide the browser version, the operating system, and the IP address of the computer in use. This Non-PII is collected from web users to assist in the proper function of our Services, as well as the targeting of advertisements sent by our customers and the reporting of aggregate data to both Merchants and Affiliates. Affilisearch does not collect, use, sell or purchase PII.

Cookies:

Remote "cookies" on web user computers and server databases at Affilisearch facilities are used by Affilisearch in connection with the Technology to store information. When used in connection with the Technology, a cookie is a piece of data placed on the web user's hard drive by our servers. Cookies are used to improve the experience web users have when they see web advertisements. Cookies are not viruses and cannot erase web users' hard drives or otherwise damage web users' computers. Usage of a cookie is in no way linked to any PII.

We use cookies to ensure that when a web user clicks on an advertisement, he/she is sent to the correct click-through destination. They are also used by our reporting system to estimate the total reach of an ad campaign, as well as frequency of display. This allows Merchants to determine with greater accuracy the composition of the audience that they reach. Cookies are also used to sequence the delivery of a series of advertisements to a web browser, and to limit the number of times a web browser receives any one advertisement. In the course of serving advertisements to target websites, our Merchants may place or recognise a cookie on visiting web users' browsers.

Web users have the option of blocking the use of cookies by changing a setting in their browser. Web users can check their browser supplier's website for details on how to do this.

Information Sharing:

Web user information obtained by and through the Technology (all of which is Non-PII) is shared with our Merchants and Affiliates on an aggregate basis. This means, for example, that of the millions of web users that we deliver banners to each month, a Merchant will know what percentage of those users viewed their advertisement with a certain browser. The sharing of this information is essential to providing the Services that we offer. Affilisearch may augment web user information with additional Non-PII, such as adding an IP address to a 7-alpha numeric postal code in order to cross-reference in an effort to improve local targeting of advertising. IP addresses are not linked to PII by Affilisearch.

Third Party Advertising

In connection with the Technology we use third-party advertising companies to serve advertisements when web users visit the websites on which we serve advertisements. These companies may use information (not including



web users' names, addresses, email addresses and telephone numbers) about such web users' visits to those websites in order to provide future advertisements on those websites that may be of interest to such web users.
